

The National Park Service records contain significant historical and anthropological reports of historic sites; environmental, biological, zoological, and ecological studies of conditions in National Park Service reserves; investigations of proposed national, state, and local parks and monuments; and construction project files of the Civilian Conservation Corps (CCC). The records generally include correspondence, statistical reports, newspaper clippings, maps, and photographs.

In addition to records of the National Park Service, this exhibit features items from two other record groups. The photo on the front cover of this brochure features a section of the famed Route 66. It is from Record Group 21, the United States District Court, Eastern District of Missouri, St. Louis (photo id: 21.MoSt.L.817).

All of the colorful postcards featuring California and the homes of movie stars come from Record

Group 129, Records of the Bureau of Prisons. All were sent to inmate #32920 at Leavenworth Federal Penitentiary. The postcards were confiscated as they were considered contraband and made a part of his inmate case file.

Original records may be viewed in the textual research room, Monday – Friday, 8 a.m. – 4 p.m. An appointment is highly recommended, so that an archivist may discuss your research topic with you and have the records you wish to see ready upon your arrival. Call (816) 268-8000.
