The electronic messages are archived and stored permanently for all our Capstone Officials. The electronic messages covered by Capstone applies to all categories reported by HRSA in this attachment. When Capstone official is offboarded, we export the electronic text messages from their returned mobile device into a PDF file for recordkeeping. The emails of Capstone Officials are kept permanent the time when the Capstone official onboards. For Capstone officials we follow GRS 6.1, Item 010 (Permanent. Cutoff and transfer in accordance with the agency's approved NA 1005, Verification for Implementing GRS 6.1). This will be between 15 and 30 years, or after declassification review (when applicable), whichever is later. Lastly, these records are transferred as a direct offer to the National Archives and Records Administration after the individual departs the agency.

**Category 1) The head of the agency, such as Secretary, Commissioner, Administrator, Chairman or equivalent.** The very top executive of the agency. For cabinet level agencies, this is typically a Secretary.
