Background Information

In 1985, a group of organizations (including American Baptist Churches) filed a lawsuit against the government. They claimed that the government discriminated against certain Guatemalans and Salvadorans who had filed for asylum. In 1990, the attorneys on both sides of the lawsuit agreed to settle the case outside of court. The agreement they made is commonly known as the "ABC Settlement Agreement." The ABC Settlement Agreement provided some immigration benefits for certain Guatemalans and Salvadorans.

The ABC Settlement Agreement required the government to give notice of the agreement to certain individuals. This notice is referred to as Notice 5 and was sent at the end of July 1995.

Notice 5 informed Salvadoran class members who applied for TPS that:

They had a right to new asylum adjudications.

In order to remain eligible for ABC benefits, they must apply for asylum by January 31, 1996, if an asylum application was not already on file with USCIS or EOIR.

They had the right to file a new application, even if they had an asylum application pending before USCIS or EOIR, but were not required to do so.

If class member received a Notice 5, they had 90 days from the date of notice to apply for asylum under the ABC settlement agreement.
