Background Information

CBP is responsible for securing the borders of the United States while facilitating lawful international trade and travel. CBP employs various technologies to enforce hundreds of U.S. laws and regulations at the border, including immigration and narcotics enforcement laws. BSS is a combination of surveillance technologies designed to assist CBP in detecting, identifying, apprehending, and removing persons illegally entering the United States at and between ports of entry and enforcing U.S. law. BSS may also monitor a particular individual or location as part of a law enforcement investigation, and as potential evidence if the apprehension of the individual results in criminal proceedings. BSS that are located across urban, rural, and remote areas along the U.S. border include tethered aerial video; radars: fixed, mobile, and relocatable towers equipped with ground video with day and night thermal capabilities; ground sensors; radio frequency sensors: ultra-light aircraft detection; and acoustic sensing devices. Each surveillance system is deployed taking into account the surrounding terrain and population.

The recorded data results in two types of audio/visual surveillance files: 1) files that have no evidentiary value; and 2) files that have evidentiary value. For use in this schedule, the following definitions apply: Non-Evidentiary- generated by BSS, including information recorded on a routine or 24/7 basis, and determined not to be evidentiary, as defined below.

Evidentiary- Any recorded data or information determined to have material, probative, or operational value, or deemed likely to have bearing on or be subject to obligations in any criminal, administrative, civil, or other legal proceeding. Surveillance files determined to have evidentiary value shall be preserved with the associated case file or other operational records, and under the associated record's approved retention schedule.

Non-Evidentiary Border Surveillance Audio/Video Records

DAA-0568-2018-0002-0001 **Disposition Authority Number**

BSS use aerial, mobile, and ground fixed cameras and radar to routinely monitor border areas for suspicious activity or an unexpected presence. Some video cameras have night vision or thermal imaging capability for monitoring an area at night. The video records and tracks the presence of people illegally crossing the border and entering U.S. territory. The systems also receive data sent by underground sensors to detect persons or vehicular movement across and along the border and relays the data to a Border Patrol station for a response. CBP also collects radar data to detect and interdict aircraft, vehicles, vessels, and other conveyances in the border area and drug trafficking transit zones, such as the adjacent portions of the Caribbean Sea. This radar data do not contain PII, but may be used to locate an individual illegally crossing the border. CBP also uses surveillance systems to detect individuals and conveyances moving above ground in remote areas, which may lead to an interdiction. They also detect the presence of small aircraft flying along the border. These records include the metadata associated with them, both system created and input by CBP employees.
