Item Description	<p>Records in this series include data submitted to the CFTC by market participants, other acquired data, or value-added data sets. Data may include files from the exchanges, including all bid/ask activity on futures, options on futures and swaps markets; data from derivatives clearing organizations; data from swap data repositories; Bitcoin auction data; other market position or transaction data submitted to the CFTC; and other data hosted in the CFTC's environment. These data collections allow the CFTC to monitor market participant's practices through robust, sophisticated analyses that inform the CFTC's examinations, enforcement, rulemaking, and other market oversight activities. These data sets may be unaggregated, raw data; prepared or augmented data; or aggregated data.</p> <p>Data relevance and retention fluctuates with the ever-changing market. New and burgeoning commodities or assets require technological enhancements for evaluation and may require revision of existing statute and regulation or the need to develop and codify new regulation. As such, the disposition of these data needs to accommodate the ingest of new data and the disposal of outmoded data based on market activity and the current regulatory environment, while still enabling staff to identify and retain select older data in order to maintain a solid reference dataset for ongoing analyses.</p>

This data comprises a snap-shot or time-capsule of the event that is used for tracking, forecasting, and comparing past and future events. Actions that might trigger a notable market event may include:</p> <ul style="list-style-type: none"> <li>•Exaggerated drops in buy-side liquidity</li> <li>•Overinflated sell orders</li> <li>•Overvalued stocks or commodities or economic bubbles</li> <li>•Excessive speculation</li> <li>•Commodity stockpiling</li> <li>•Forced and panicked selling</li> <li>•Halt in trading of a particular commodity</li> <li>•Temporary ban on trading certain asset types</li> <li>•Environmental impacts or natural catastrophes</li> <li>•Political referenda, economic downgrade, civil unrest and demonetization</li> <li>•Critical announcements or changes to rules, laws or technology that govern trading</li> <li>•Unusual activity uncovered by Mission Divisions in the course of research, analysis or investigations</li> </ul>
