# CERTIFICATE OF ASCERTAINMENT OF APPOINTMENT OF ELECTORS OF PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES

## **TO: ARCHIVIST OF THE UNITED STATES**

WHEREAS, 3 U.S.C. 5 requires that the State of Alaska transmit to your office the following electors of President and Vice President of the United States; and

WHEREAS, Alaska Statute 15.30.010 provides that electors of President and Vice President of the United States are selected by election at the General Election in presidential years; and

WHEREAS, under Alaska Statute 15.30.050, a vote marked for the candidates for President and Vice President is considered and counted as a vote for the presidential electors of the party or the independent candidate; and

WHEREAS, pursuant to Alaska Statutes 15.30.020 and AS 15.30.026, following are three candidates for electors for each party with a candidate for President and Vice President and for each independent candidate on the 2024 General Election ballot.

WHEREAS, pursuant to the Act of June 25, 1948, 62 Stat. 672, as amended, 3 U.S.C. 5, Michael Dunleavy, Governor, and Nancy Dahlstrom, Lieutenant Governor, do solemnly certify that in the General Election of November 5, 2024, the votes cast for President and Vice President, respectively, were 140,026 votes cast for Kamala D. Harris and Tim Walz of the Democratic Party; 184,458 votes cast for Donald J. Trump and JD Vance of the Republican Party; 3,040 votes cast for Chase Oliver and Mike ter Maat of the Libertarian Party; 702 votes cast for Peter Sonski and Lauren Onak of the American Solidarity Party; 1,127 votes cast for Cornel West and Melina Abdullah of the Aurora Party; 812 votes cast for Randall A. Terry and Stephen E. Broden of the Constitution Party; 2,342 votes cast for Jill Stein and Rudolph Ware as independent candidates; and 5,670 votes cast for Robert F. Kennedy Jr. and Nicole Shanahan as independent candidates.
