AMENDED CERTIFICATE OF ASCERTAINMENT OF PRESIDENTIAL ELECTORS

IN THE NAME AND BY THE AUTHORITY OF THE

COMMONWEALTH OF PENNSYLVANIA

Pursuant to the Laws of the United States, I, Josh Shapiro, Governor of the Commonwealth of Pennsylvania, do hereby certify that in accordance with the provisions of the Pennsylvania Election Code, Act of June 3, 1937 (P.L. 1333, No. 320), the Secretary of the Commonwealth, on receiving and computing the returns of the election of Presidential Electors, shall lay them before the Governor, who shall enumerate and ascertain the number of votes given for each person so voted for, and shall cause a certificate of election to be delivered to each person so chosen. It appears from the returns so laid before me by the Secretary of the Commonwealth, that at an election for that purpose held on the Tuesday next following the first Monday in November, being the fifth day of November, 2024, the votes given for each person so voted for were:


