Do hereby Certify, That the said Electors of President and Vice President of the United States for the State of New York, as by law required, convened at the Capitol of the said State, in the City of Albany, on the seventeenth day of December, in the year two thousand twenty four, at twelve o'clock noon of that day;

And we do hereby further Certify, That, being so assembled and duly organized, we proceeded to vote by ballot, first for such President, and then for such Vice President, by distinct ballots;
