DO HEREBY CERTIFY, THAT, BEING SO ASSEMBLED AND DULY ORGANIZED, WE PROCEEDED TO VOTE BY BALLOT, AND BALLOTTED FIRST FOR SUCH PRESIDENT, AND THEN SUCH VICE-PRESIDENT, BY DISTINCT BALLOTS;

AND WE FURTHER CERTIFY, THAT THE FOLLOWING ARE TWO DISTINCT LISTS; ONE, OF THE VOTES CAST FOR PRESIDENT, AND THE OTHER, OF THE VOTES FOR VICE PRESIDENT, SO CAST AS AFORESAID.
