NARA OIG was notified that on November 2nd, NARA's Office of General Counsel (NGC) received information from President Biden's White House Counsel concerning boxes of records and other items related to President Biden's tenure as Vice President dating to approximately 2013-2019. Specifically, NGC reported the following information to NARA OIG:

Approximately 50 to 60 boxes of records were located in an office previously used by President Biden

- at the Penn Biden Center office in Washington, DC. It was reported that during a precursory inspection of those boxes, some records containing classified markings were identified.
- 3 boxes that were identified as containing these classified materials and other potential PRA records were retrieved by NARA on November 3rd. NARA completed a review of the documents in those boxes and identified 9 classified records totaling 44 pages (Confidential and TSCI classifications). These records are currently maintained in a NARA SCIF.
- 8 to 10 boxes of records were identified as containing personal effects and were retrieved by an attorney working with President Biden for additional review (not in NARA custody).
- 15 boxes contained materials related to Beau Biden's death (not in NARA custody).
- 10 boxes contained materials related to the DNC Campaign (from President Biden's previous campaign efforts not in NARA custody).
- Approximately 30 additional boxes remain at the Penn Biden Center office in Washington, DC, awaiting
 further review. NARA anticipates retrieval of these boxes as early as Monday, and the exact contents
