

NARA Notice 2022-027: Four More Facilities Progress to Substantial Workplace Safety Measures

Mon, November 1, 2021



To: All Employees.

Attention supervisors: If you have employees who do not have access to a computer, please ensure that those employees receive a copy of this notice. This includes employees on LWOP or paid leave.

I have authorized the following facilities to implement the workplace safety measures associated with substantial transmission levels in our Updated Reentry and Post-Reentry Plan:

- William J. Clinton Presidential Library in Little Rock, AR,
- · Kansas City Federal Records Center (FRC) in Kansas City, MO,
- · New York Archives in New York, NY, and
- · Lyndon B. Johnson Presidential Library in Austin, TX.

Effective today, these four facilities will no longer be subject to an occupancy limit for staff. Beginning November 8, managers at these facilities are authorized to require staff to report to the facility when they are needed for on-site work, and staff there are no longer eligible for incentive payments for on-site work. The Clinton and Johnson Museums will expand occupancy to 50 percent of pre-COVID-19 levels beginning today. The research rooms at the Clinton and Johnson Libraries will reopen to the public at 50 percent occupancy beginning the week of November 8. The research room at the New York Archives will reopen to the public on December 1.

All four facilities are located in counties that have experienced weekly public health metrics of 99 or fewer new cases per 100,000 population and less than 10 percent positivity for at least the past three consecutive weeks. New case and positivity data for each NARA facility will be posted later today to the here. Staff should not return to the worksite until you are contacted by your supervisor and have scheduled your return.

Please take care of yourselves and each other. If you need support or assistance coping with the stress of the pandemic, please take advantage of the Employee Assistance Program (EAP). As of today, seven of NARA's 40 occupied facilities have implemented the workplace safety measures associated with substantial transmission levels. All other facilities must maintain safety measures associated with high transmission levels. NARA facilities may progress from high to substantial transmission if they experience at least three consecutive weeks of local public health metrics associated with substantial transmission levels and only after I have authorized them to progress. We will continue to monitor local public health metrics at all NARA facilities and will reopen or close additional facilities when local conditions require a change in NARA's operating status.

Thank you for your patience and flexibility as we carefully reopen our facilities and begin to restore our mission functions and operations, where appropriate.
