1. ALTHOUGH LEONOV INTERESTING TARGET WE CANNOT GUARANTEE
 SUBJ OF REF THAT CONTACTS WITH THE SOVS EVEN IF UNDER OUR AUSPICES
 WOULD NOT JEOPARDIZE HIS CHANCES TO OBTAIN SECURITY CLEARANCE
 NEEDED FOR GOVT POSITION. WE ARE REQUIRED TO INFORM OSOVY OF
 SOV CONTACTS WITH PEPRIME CITIZENS WHEN THE CITIZEN RETURNS TO
 PEPRIME. IF QUESTIONED BY OTHER OSOVY AGENCIES RE SUBJ AS PART
 OF NORMAL SECURITY INVESTIGATION WE COULD RELATE FACT THAT SUBJ
 WAS MEETING SOVS AT OUR BEHALF AND GIVE THEM ESTIMATE OF SUBJ'S
 LOYALTY AND HIS CONTRIBUTION TO US. WE COULD ALSO GIVE SAME
 TYPE DATA TO AGENCIES WITH WHICH SUBJ IS APPLYING FOR EMPLOYMENT
 AT OUR OWN INITITIVE. EVEN IF OUR ASSESSMENT WAS FAVORABLE WE
 CAN ONLY RECOMMEND AND CANNOT DICTATE PERSONNEL AND SECURITY
 POLICIES OF OTHER AGENCIES. WE MAY NOT BE ABLE TO CONVINCE
 OTHER AGENCIES THAT SUBJ IS NOT UNDER SOV CONTROL. THIS
 SHOULD BE POINTED OUT TO SUBJ AND IF A GUARANTEE IS A CONDITION

FOR HIS WORKING WITH US THIS ALONE WOULD PRECLUDE DEVELOPMENT OF THE OP.

2. IN ADDITION WE WONDER IF OP USING SUBJ WOULD BE PRODUCTIVE TO KUBARK. POSSIBLE AND LOGICAL SOV TACTIC (ESPECIALLY IF THEY KNOW HE IS INTERESTED IN GOVT EMPLOYMENT) WOULD BE TO DEVELOP SLOWLY FOR OUR USE AT LATER DATE. THIS TYPE OP MAY DRAG ON FOR YEARS WITH NO BENEFIT TO KUBARK.

3. INFER FROM REF THAT INITIAL CUSTODIAN ASSESSMENT SUBJ NOT EXTREMELY FAVORABLE AND MUST CONSIDER LENOVO EXPERIENCED INTELLIGENCE OFFICER WHO WOULD NO DOUBT MAINTAIN UPPER HAND IN RELATIONSHIP WITH 20 YEAR OLD STUDENT. ALSO EVEN IF SUBJ WOULD ACCEPT KUBARK ROLE KNOWING FUTURE RISKS HE MIGHT HAVE RESERVATIONS LATER AND BECOME HANDLING PROBLEM.

4. LENOVO APPEARS TO BE ROB SPECIALIST POLITICAL ACTION LATIN AMERICA. SENSITIVE ⁰² AESTORAGE REPORT IDENTIFIES HIM AS ROB. FEEL IT WOULD BE ADVANTAGEOUS HAVE A SOURCE IN DIRECT CONTACT WITH HIM BUT IN VIEW SUBJ'S SITUATION FEEL HE SHOULD NOT BE ASKED TO TAKE THE ASSIGNMENT.
