SYNOPSIS

Per his request, 2nd Lt. Oliverio Antonio TOMBU Vassallo was recontacted on 8 June 64 at his place of residence. He provided additional details on [redacted] and [redacted] and identified Osiel GONZALEZ and one "COCO" as possible leads to Jose LLANERA Gobel.

CONTACT REPORT

SUBJECT: Recontact of Oliverio A. TOMBU Vasallo. (201-283206)

1. At 1730 hours, 8 June 64, the undersigned was advised at his residence that a Mr. TOMBU (Subject) had called the security number given him (351-8161) and left the message that he would like to talk again with Paul Stroud (the undersigned) anytime after 1800 hours, 8 June.

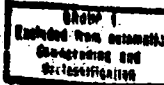
2. Upon arriving at TOMBU's apartment (Apt. 303, 1028 Wahler Place SE, High Point Apartment House, Washington, D. C.), 1830 hours, 8 June, TOMBU indicated to his two daughters he would like to have some privacy and they and his wife, Caridad, left the apartment.

3. TOMBU apologized for not having recalled the name [redacted] as that of [redacted]. He reiterated that, while in hiding to escape capture by the Cuban Government subsequent to his infiltration, he knew only the first names of the persons with whom he came in contact, but then added he knew [redacted] in whose house he was hiding, because she was the sister of [redacted] one of his infiltration team members. (This [redacted] may be identical with one [redacted] 201-289985; or one [redacted] 201-283206.)

4. On several occasions, according to TOMBU, he was seated at the table in Ann's house with several other people. One of these individuals, known to TOMBU only as "COCO," was described as the secretary to Jose LLANUZA Gobel. There was not, however, any discussions in which TOMBU recalls LLANUZA or his political sympathies having been discussed. According to TOMBU's recollection it was "COCO" who was associated with LLANUZA, and he was not aware of any relationship between [redacted] and LLANUZA. Although TOMBU had no information as to what finally happened to [redacted] is infiltration team mate, he suggested that if [redacted] or [redacted] were available they may be able to identify "COCO" and provide data on his accessibility for contact.

5. One Cziel GONZALEZ, former Chief of the Havana Fire Department, was identified by TOMBU as another possible lead

who would know LLANUZA. TOMBU affirmed Osiel was previously with MEMOYO Outierrez in the Second Front of Escambray. Osiel was under asylum in the Brazilian Embassy (sic, Argentine Embassy?), when TOMBU gained political asylum. When Osiel finally received his safe conduct from the Embassy, he went to Puerto Rico and, TOMBU postulates that Osiel is now again with MEMOYO in either the United States or Puerto Rico.

6. Two snap shots (to be returned) were provided by TOMBU of himself and six other individuals who were in asylum at the same time. He identified these, in the photograph in which [redacted] is seated, as, from left to right: Manuel VILLAMANAN, Oliverio TOMBU, [redacted] (believed to be in US), Publico RUIZ (US), Jorge DEL VALLE (Mex?), and Osiel GONZALEZ (US or Puerto Rico?).

7. Upon completing the debriefing, Stroud and TOMBU "exchanged small talk" for a while until TOMBU finally stated that he still wished there was something more he could do to help free Cuba, and asked "What do you think I should do?" Stroud replied that no person could really make that type of decision for another individual, and countered by asking TOMBU what alternatives he had in mind, other than remaining in the US Army as a career military officer.

8. TOMBU replied that, of course, he was once an agriculturalist, but that there were few job opportunities in which he could apply his past experience. His sister had also asked him if he felt he and his family would want to live with her in Spain or Mexico, but he didn't think too much of this idea. He then stated that he had been asked by Manuel ARTIME to take a job as an instructor. Without indicating any association of even awareness of ARTIME's activities, or of ARTIME's contact with TOMBU (as indicated in TOMBU's 201), TOMBU was asked what he thought of ARTIME's proposition. TOMBU stated that he would no longer follow any man as an individual or as a leader, because a man's ideals, outlook, and objectives change with time. For example, the people of Cuba followed Fidel because of the ideals he advocated. When Fidel took over, his accomplishments gradually became quite different from the ideals he had espoused. TOMBU continued by saying he would "no longer follow a man. One could only trust his ideals or an organization which followed those ideals, since a good organization would be less likely of being controlled by a single man." When asked for an example of the type of organization he had in mind, TOMBU replied he was most favorably inclined towards the ideals and goals of the JURE. (The JURE or JEC is an organization created by Manolo RAY Rivero around a nucleus of former 26 July Movement leaders. See memo and attachment dated 23 July 1963 from John Hugh Crissins, Coordinator of Cuban Affairs, ARA, Department of State in TOMBU's 201-283206.)

It should, perhaps, be noted here that in an informal exchange with Mrs. Donald WEBSTER, TOMBU's supervisor at the Defense Language Institute, Anacostia Naval Annex, 4 June 64, Mrs. WEBSTER volunteered the information that "all of the other 'Brigade students here' have told me they think very highly of TOMBU, and that he is a very brave man, because he and his family were very wealthy in Cuba and he gave it all up to go into exile and fight the Castro Regime."
