REQ CONTACT WITH ANHAK FOR PURPOSE DISCUSSING CONTENTS REF AND DELIVERY MESSAGE FROM RUISANCHEZ FORWARDED HKHA-6359 NOT POSSIBLE UNTIL EARLY JULY. IRRESPECTIVE YOU SHOULD CONTINUE DISCOURAGE ANY FURTHER CONTACT. WILL ADVISE WHEN MATTER DISCUSSED WITH ANHAK.

Comment: Said Station officer met with Ramon RUISANCHEZ Piedad, brother-in-law of ANHAK, on 17 June, through AMANHEM, on RUISANCHEZ request, who gave info he wanted passed to ANHAK re a group of 200 disaffected Cuban Army officers in Las Villas, and requested guidance from Station officer re use of group as well as assistance in exfiltrating one officer to U.S. Station officer replied RUISANCHEZ certainly must have some channels to ANHAK in U.S. and saw no need of involving U.S. Embassy in matter. R. replied that U.S. State Dept already being used, but when asked would not give name of contact, saying could not violate trust. Since this not channel originally set up for contact with ANHAK group HAVA, Station will discourage future relationship with RUISANCHEZ. Suggested ANHAK be queried and requested Hqs views.
