The following report is one of a series containing personality information provided by the source and includes supplemental information from the records of this Agency.

It is requested that the addressees take no action on any of the individuals mentioned in the personality reports without first checking with this Agency.

1. "Alberto" is employed by the Direccion General de Inteligencia (General Directorate of Intelligence - DGI) and handles the liaison with airport personnel concerning the entry and exit of foreigners who are of interest to the DGI. He carries a carnet of the Cuban Ministry of Interior.

2. "Alberto" is a Cuban citizen and was born in about 1925. He is five feet seven inches tall, weighs 150 pounds, and has a medium build. "Alberto" has a white complexion, blond, wavy hair, a short, thin, blond and greying mustache, and light colored eyes.
