1. RE REF A AND PARA 1D REF B REQUEST WAVE ADVISE AMSCROLL NOT RELEASE BLACK LIST CORPORATIONS TRADING WITH PERUMEN.
2. RELEASE OF BLACK LIST COULD PREJUDICE CERTAIN PROPOSALS WHICH ODACID PERUMEN COORDINATOR ATTEMPTING PUSH THROUGH ODACID AT THIS TIME. VIEW PROBABILITY LIST WOULD ALSO BE INCOMPLETE, THE THREAT OF PUBLISHING LIST WOULD BE MORE EFFECTIVE DETERRENT TO THOSE NOW TRADING OR PLANNING TRADE PERUMEN.
3. PUBLICITY REGARDING LIST AND LETTERS ADDRESSED TO FIRMS ARE EFFECTIVE AND SHOULD BE ENCOURAGED.
4. AGREE WAVE SHOULD GIVE BRUS ADVANCE NOTICE ON FIRMS AFFECTED BRUS AREA. HOWEVER BELIEVE WOULD BE INAPPROPRIATE APPROACH AMSCROLL ON BEHALF ANY FIRMS. SUGGEST BRUS ADVISE NIFANG AND ANY OTHERS INVOLVED THAT AMSCROLL ACTION IS UNILATERAL BUT KUBARK WILL TRY PREVENT PUBLICATION BLACK LIST.
