FYI HIGHER AUTHORITY ADVISED AMBUD-1 HE WOULD BE ALLOCATED ADMIN BUDGET NEIGHBORHOOD DYPAT DYNUR PER YEAR WITH CONSIDERABLE FLEXIBILITY USE THIS MONEY; AND THAT ALLOCATIONS OF MONEY FOR ALL OTHER ACTIVITIES, INCLUDING MOST PROP AND ALL CLANDESTINE OPS INTO CUBA, WOULD BE ON BASIS SPECIFIC PROJECTS SUBMITTED GOYDGE FOR APPROVAL.

2. ABOVE COMMITMENT IMPLIED EFFECTIVE INTEGRATION AMINCH INTO AMBUD WHICH ACCORDING PRESS RELEASE 7 SEPT WAS TO BE FORMALIZED WITHIN WEEK OR TWO. THEREFORE PAYMENT ON COMMITMENT TO AMBUD-1 WAS PREDICATED UPON ELIMINATION AMIRON BUDGET.

3. PER DISCUSSIONS AMBUD-1 ZRMETAL AMBUD-1 WILL SUBMIT ACCOUNTINGS ALL EXPENDITURES TO AMTIKI-1.

4. HQS REACTION PARA 3 B IS THIS SHOULD PROBABLY BE ELIMINATED IN REORGANIZATION OF FUNDING AND ADMIN PROCEDURES OF AMBUD-1.
