MARTIN ADDRESS OR TELEPHONE NUMBER WOULD BE INVESTIGATIVE LEADS. IF AMBUD-1 MEETS AGAIN WITH MARTIN SUGGEST WAVE IF FEASIBLE SURVEILL POSSIBLY LOCAL ODENVY OR POLICE MIGHT HAVE INFO. REPORT ANY INFO DEVELOPED.
3. FYI INVESTIGATION INCLUDED CHECK WITH BAHAMAS DEVELOPMENT BOARD AND BRITISH CONSULATE NEITHER OF WHOM HAD HEARD OF COMPANY OR MARTIN.
