2. HQS NOTES IN REF B THAT JESUS MARINAS MAY NOW BE AT LIBERTY. REQUEST CONFIRMATION. IF THIS REPORT INACCURATE AND MARINAS STILL PERSONA NON GRATA WITH GOVT, WOULD PRESENT TIME BE PROPITIOUS FOR CUBAN REVOLUTIONARY COUNCIL CHIEF OR OTHER REPRESENTATIVE OF CUBAN ANTI-CASTRO FORCES TO SEEK AUDIENCE WITH PRESIDENT PAZ ON BEHALF MARINAS?

3. FOR WAVE: CONTRARY TO INFO IN REF C, REF B SAID MARINAS WAS ARRESTED ONLY DUE TO IRREGULARITY OF DOCUMENTS AND HAS BEEN RELEASED. HAS AMBUO ANY INDEPENDENT INFO AND DO THEY CONTEMPLATE TAKING ACTION ON BEHALF OF MARINAS'.
