1. ⁰² (Q)SPORT 1 REPORT OF 5 APRIL MEETING WITH ANWHIP 1 AND ANLASH 2 QUOTES LATTER AS SAYING ⁰² (Q)HOPS DID NOT WANT ANY MORE PHONE CALLS AND INTENDED TO TELL THIS TO OLIEH.

2. AT 5 APRIL MEETING WITH GROWERY, ANWHIP 1 DISCUSSED HIS MEETING OF 4 APRIL WITH ⁰² (Q)HOPS, ⁰² (Q)SPORT AND ANLASH 2 AND 3, QUOTING ⁰² (Q)HOPS AS STATING:

A. ⁰² (Q)UALT DEFECTION ADDED TO PRESTIGE OF ⁰² (Q)HOPS AT MADR EMBASSY AND AT PBRUMEN FOREIGN OFFICE (THIS DOES NOT JIBE WITH ⁰² (Q)DOZE INFO FORWARDED REF B).

B. ⁰² (Q)HOPS BE REASSIGNED MADR AS FIRST SECRETARY.

C. REPEATED PHONE CALLS FROM OLIEH INDICATE ODYOKE DESIRE TO MAKE ⁰² (Q)HOPS AN "AGENT". ⁰² (Q)HOPS IS A GOVT OFFICIAL AND DOES NOT WISH TO BE AGENT. ODYOKE WANTS TO TRAIN ⁰² (Q)HOPS BUT HE DOES NOT WANT TO BECOME INVOLVED.

D. ⁰²QUNHOPS WILL NOT RESPOND TO PHONE CALLS OR ATTEND ANY MEETINGS WITH ODYOKERS.

3. AMWHIP 1 EXPRESSED BELIEF KUBARK SHOULD NOT CONTACT ⁰²QUNHOPS.

4. NO NEW PERTINENT ⁰²QUNDOZE MATERIAL PRESENTLY AVAILABLE.

5. WITH REGARD TO 2A ABOVE, ¹⁵⁻²[STATION] HAS NO HARD INFO AS TO BASIS FOR ⁰²QUNHOPS REASONING. HOWEVER ON 23 MARCH ⁰²QUNHOPS TOLD OLIEH THAT HE HAD FOUND AT EMBASSY COPY OF ⁰²QUNMALT LETTER TO ROGELIO PATINO IGLESIAS IN WHICH ⁰²QUNMALT EXPRESSED SUSPICION THAT ⁰²QUNHOPS WAS RECEIVING FUNDS FROM ODYCKE. ⁰²QUNHOPS SAID HE HAD KEPT COPY. IT MAY BE THAT HE RECENTLY HAS SHOWN LETTER TO MINISTER REASONING THAT CONDEMNATION BY ⁰²QUNMALT WOULD SERVE TO PROVE THAT ⁰²QUNMALT AND ⁰²QUNHOPS WERE NOT SUCH GOOD FRIENDS AS OTHERS BELIEVED AND THAT THERE WAS NO COLLUSION BETWEEN THEM.
