1. TELEPHONE RECEIVED COPY OF LETTER FROM [REDACTED] TO APRIL COFFO OFFERING HIM JOB AS ORGANIZER IN 1964 AND AUTHORIZING HIM TO GO MEET FOR ORGANIZERS CONFERENCE. TELEPHONE POINTED OUT COFFO'S UNLAWFUL REFUSION AND SUGGESTED CHECK WITH OWNERS.

2. OWNERS SAYS HE WOULD NOT HIRE COFFO UNDER ANY CIRCUMSTANCES. HE CONSIDERS COFFO A CROOK, ONLY INTERESTED IN MONEY AND UNDOUBTEDLY WOULD BRING IN POLITICAL WHOLE OF THEODORE HAYBALL. OWNERS SAYS COFFO WAS CHIEF FINANCIAL OF MANAGEMENT OF FUND, NOT IN CHARGE HOWEVER THIS COMPANY A TECHNICALITY AND HE OWES \$125,000. TELEPHONE SAYS HE WILL BE ANOTHER REFUSAL. THIS OFFER MADE WITHOUT OWNERS KNOWLEDGE.

3. COFFO EMPHATICALLY HAS GROWN TIES WITH CIO AND PARTICULARLY RAY BENTLEY. HIS BELIEVES OWNERS AND HIS CONSPIRACIOUS COURT SHOULD BE SERIOUSLY CONSIDERED INCLUDING WITHIN OTHER. FUNDING FUTURE COULD BE BY APPROVAL OF ONLY SIX MONTHS BUDGET. WHILE NEGOTIATED REALIZES TELEPHONE MAY HAVE BELIEVED COFFO BELIEVE HE SHOULD GIVE SERIOUS CONSIDERATION TO OFFICE OF U.S. ATTORNEY. OWNERS AUTHORIZED CHECK TO SPECIAL FUNDS WILL BE AVAILABLE FOR ANY FUNDING HANDLED BY COFFO.
