  - A. SAOP SURFACE SUITABLY ENLIGHTENED STUDY BASED ON PARA 1 INFO.  
SHOW THAT NEEDING IS INDICATION COVERT RESEARCHER WANTED ABOUT CASERO  
BEING CASERO HED BLAMES.
  - B. ON PUBLICATION, SAOP CALLS SOCIETY OF STUDY TO INFO AGENCIES FOR  
REPLAY  
REPLY VIA EDITORIAL COMMENT. SEND CLIPS AGENCIES AND SAFEGUARD EYE.
3. IF SAOP OR INFO AGENCIES ABLIE CONFIRM REPORT, CASE RESULTS INDICATING  
WHETHER CAN BE USED FOR REVEAL PURPOSES IN FOLLOW UP STORIES. IF RESULTS IN FACT  
PLANNED, BELIEVE SOURCES WILL BEING CASE CANCELLATION OR AT LEAST DISCOURAGE  
PARTICIPATION.
