On 4/17/61, MM 492-S advised that RAMON IGLESIAS VASALLO, former President of the Dental Assoc., Havana, Cuba, received mail at 2536 S.W. 11th St., Miami, Fla., in the name of RAMON MENDEZ. MM 492-S advised that IGLESIAS was a member of the Frente Revolucionario Democratico (FRD) and had been actively engaged in counterrevolutionary activities against the FIDEL CASTRO Government of Cuba. Informant stated IGLESIAS was expelled from Cuba and arrived in the U.S. in the guise of a priest of the Catholic faith.

On 4/4 and 4/19/61, Inspector WILLIAM BOYD, INS, Miami, advised he was unable to locate any record identifiable with subject under either above mentioned name.

On 5/3/61, [WILLIAM MC CLAIRE] CIA Covert, Miami, advised CIA had an operational interest in RAMON IGLESIAS VASALLO. He stated IGLESIAS resides at 2749 S.W. 5th St., Miami telephone HI 3-4855, and uses the name RAMON MENDEZ and receives mail at 2536 S.W. 11th St., Miami. [MC CLAIRE] also advised that IGLESIAS had at one
