ADMINISTRATIVE:

MARCELLO has been the subject of extensive news media reporting in the past three months under his alleged association with AUBREY YOUNG and other political figures in Baton Rouge, Louisiana. None of this information from the news media being incorporated in this report. This matter has resolved itself into a political fight in Louisiana as to who is and who is not controlled by MARCELLO.

On January 25, 1968, NO 1232-C-TE provided information relative to the fact that CARLOS MARCELLO was attempting to bribe EDWARD GRADY PARTIN in the amount of \$50,000 to change testimony he had previously given in a U. S. District Court resulting in the confinement of JAMES HOFFA, teamster unit official. Informant advised that he had recently talked to CYRIL PORETTO who told him that JOSEPH PORETTO, close associate of MARCELLO, advised him that he had observed the \$50,000 in an attache case he was carrying. MARCELLO told JOSEPH PORETTO that this \$50,000 was for PARTIN. JOSEPH PORETTO claims that he strongly recommended that MARCELLO not involve himself in the HOFFA matter.
