GEORGE HOPKINS, Manager, and KAREN CANTOR, PCI, Switchboard Operator, Glen Towers Apartments, 1333 South Beverly Glen Boulevard, Los Angeles, advised that ROSSELLI and his current girl friend, NANCY CZAR (CZARNECKI), who is living at the apartment with ROSSELLI, left the apartment on 5/24/65 and did not return until 6/3/65. Both ROSSELLI and CZAR have been at the apartment since their return.

The Las Vegas Office advised that ROSSELLI was at the Desert Inn Hotel in Las Vegas from June 1 or 2 until the evening of June 3, 1965, when he departed for Los Angeles via TWA.

An informant advised that NANCY CZAR told him recently that she is going with JOHN ROSSELLI and that ROSSELLI told her that if the FBI comes to talk to her she should tell them that she would only talk to them in the presence of her attorney. She also said that ROSSELLI was an important man.

Examination of the EMANUEL ROTHMAN, Trustee Account (Union Bank, Los Angeles), which is used for financial activities of ROSSELLI reflects a deposit on 5/4/65 of \$5,000 in the form of a check drawn on the Fidelity Bank, Beverly Hills, California, where ROSSELLI maintains his personal bank account.
