[On 2/14/61, PSI FELIX VALDES, (protect identity), [u] who has furnished reliable information in the past, advised that subject is a married Cuban who belongs to the Frente Revolucionario Democratico (FRD) and he is being sent by that organization from Mexico to a camp in the vicinity of Miami, Florida. [PSI stated that he has ascertained through persons who know subject that he is a student of petroleum engineering and that he worked in the Instituto Nacional de Reforma Agraria (INRA) together with one NUNES JIMENEZ in Havana, Cuba. (u)]

[PSI stated that] anti-CASTRO Cubans had some doubts about subject and they confidentially leaked some information to him about some event within Cuba and it was learned that subject had informed on this matter. [PSI stated that] it is suspected that although subject might be within the FRD, he may be a Communist, although [the PSI had] no specific information with which to support this supposition. (u)
