Enclosed are nine copies for the Bureau and one copy each for Miami and New York of a letterhead memo with its memo of evaluation, dated and captioned as above.

The informants are identified as follows:

WF T-1 is [redacted] who furnished information to SA HERBERT J. MORGAN, Jr.

JFK Act 5 (g)(2)(D)

WF T-2 is CIA. (S)(U)

No active investigation is being conducted at this time by WFO. Based on the information in the enclosures the Bureau may desire to obtain State Department clearance for an active investigation of PINO.

The letterhead memo is classified "Secret" since the information furnished by CIA was so classified. (S)(U)

In the event of downgrading, the letterhead memo and evaluation memo should be classified "Confidential" since they reveal investigative interest in a foreign diplomatic establishment. The letterhead memo should further be classified "Confidential" since it contains information from WF T-1, a source of continuing value and the information could result in the identification of this source.

It is noted that the information in the letterhead memo furnished by the State Department was classified "Confidential."
