Kennedy Assassination Records Collection Act of 1992, I am writing to inform you that the Assassination Records Review Board has made additional formal determinations concerning the public disclosure of CIA records on September 9, 1998 and September 14, 1998.

Enclosed is a list of the determinations that the Review Board has made. These decisions were premised on several factors, including the historical interest in the documents and the absence of evidence that the release of the information would cause harm to the United States or to any individual.

You have seven days to appeal these decisions to the President. You are invited to send your representative to the Review Board to examine our copies of the documents for which determinations have been made and to discuss the determinations with my staff.

SUMMARY: The Assassination Records Review Board (Review Board) met in closed meetings on September 9, 1998 and September 14, 1998, and made formal determinations on the release of records under the President John F. Kennedy Assassination Records Collection Act of 1992 (JFK Act). By issuing this notice, the Review Board complies with the section of the JFK Act that requires the Review Board to publish the results of its decisions on a document-by-document basis in the Federal Register within 14 days of the date of the decision.

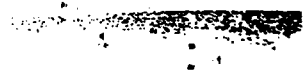
