SOURCE A COMPANY-GRADE OFFICER (F) ON THE STAFF OF GENERAL NGUYEN KHANH.

APPR KHANH MAY STILL BE THINKING ABOUT ANTI-GOVERNMENT ACTION, BUT WITHOUT ASSURANCES FROM THE UNITED STATES OF SUPPORT, HE WILL PROBABLY NOT INITIATE ANY ACTION. NEVERTHELESS, THE POSSIBILITY OF HIS MOUNTING A COUP D'ETAT CANNOT BE COMPLETELY IDISCOUNTED SINCE AN INDIVIDUAL CONNECTED WITH THE TRAN KIM TUYEN COUP GROUP HAS SAID THAT KHANH MIGHT TAKE ACTION AGAINST THE DIEM GOVERNMENT, AND SINCE KHANH'S NAME HAS BEEN MENTIONED AS ONE OF A NUMBER OF ALLEGEDLY DISSIDENT GENERALS.

ON 15 SEPTEMBER 1963 BRIGADIER GENERAL NGUYEN KHANH, CORPS COMMANDER. SAID THAT HE WOULD DECIDE IN A DAY OR TWO WHETHER OR NOT TO PROCEED WITH PLANNING ACTION AGAINST THE DIEM REGIME. (FIELD COMMENT. SEE FVS-9634, TDCSDB-3/656,637, REPORT ON KHANH'S PLANNING.) HE REMARKED THAT IF HIS DECISION WERE NEGATIVE, HE WOULD CEASE ALL PLANNING AND NOT REVIVE THE PROJECT. SEPTEMBER KHANH SAID THAT HE HAD CHANGED HIS MIND AND WOULD MULL OVER THE SITUATION FOR ANOTHER WEEK BEFORE GIVING HIS FINAL KHANH PLANNED TO RETURN TO THE 11 CORPS AREA ON 18 DECISION.
