

#### MEMORANDUM

I discussed the employment of Alan Bruce Hausman with the Chairman this morning, and he gave his approval for Mr. Hausman to be hired at a salary of \$28,000, effective June 1, 1977.

The Chairman does want it to be clear that this approval is an exception to the moratorium which the Committee has imposed on the hiring of staff at this level.

Dear Mr. Hausman:

It is with great pleasure that I welcome you to our staff and request that you report for duty as staff counsel on June 1, 1977.
