- 2. Enquiries conducted in Montreal revealed that Albert OSBORNE wrote an undated letter to the Central Branch of the Y.M.C.A., at 1441 Drummond St., requesting that his mail be forwarded to General Delivery, Detroit. The original of this letter, which bears OSBORNE's signature, is attached.
- 3. Further enquiries made in Montreal failed to uncover anyone who knew or could identify Albert OSBORNE. Enquiries are continuing in an effort to obtain more identifying data pertaining to OSBORNE and you will be advised of the results.
