FRANK PASTRO WILL BE ARRIVING IN CARACAS TO JOIN BOSCH ON VENEZUELA

HE INDICATED THAT PAST INFORMATION FURNISHED BY HIM TO THE FBI IN THE UNITED STATES SOMEHOW BECAME KNOWN TO ANTI-CASTRO ACTIVISTS IN MIAMI AND PORTIONS WERE EVEN PUBLISHED IN NEWS-PAPERS THERE, AS A RESULT OF WHICH HIS LIFE WAS ENDANGERED FOR SOME TIME. HE POINTED OUT THAT IF ANTI-CASTRO ELEMENTS BECAME COGNIZANT OF THE INFORMATION FURNISHED BY HIM, THEY WOULD BE ABLE TO IMMEDIATELY PIN-POINT HIM AS THE SOURCE AND NOT ONLY WOULD HE THEREUPON BE PLACED IN A VERY DANGEROUS POSITION BUT HE WOULD CERTAINLY BE DISMISSED FROM DISIP, WITH NO CHANCE OF AGAIN GAINING GOVERNMENT EMPLOYMENT IN VENEZUELA.
