**Scope and Content**

The materials in this series are a selective, not necessarily all-inclusive, body of records responsive to the topic of FOIA request 2014-0012-F.

FOIA case 2014-0012-F contains responsive photos from the White House Photo Office.

These photos are dated January 24, 2001 through January 20, 2009 and most were taken by David Bohrer. Other White House photographers responsible for the creation of photos found within this series include: Paul Morse, Karen Ballard, Kimberlee Hewitt, Shealah Craighead, and Chris Greenberg. The bulk of the responsive photos depict Vice President Cheney meeting alone with David Addington and in small group meetings when Addington served as his Chief of Staff from 2005 to 2009. There are also photos of David Addington when he served as Counsel to the Vice President from 2001 to 2005. The next largest segment of processed photos consists of images of President George W. Bush meeting with Vice President Cheney. The third segment depicts David Addington with other staff members. The final segment of images pertains to meetings with Department of Justice (DOJ) lawyers and David Addington by himself.

The photographs processed of Vice President Cheney meeting with David Addington depict them in one-on-one conversations at the White House, on Air Force Two and Marine Two, at official events, at the Vice President's Residence (United States Naval Observatory), on foreign and domestic trips, and at policy meetings. There are also images of David Addington with Vice President Cheney meeting foreign officials and United States ambassadors, in small group settings with other staff members, and at lunch meetings of the administration's principal economic advisors (the Economic Principals).

Other individuals depicted with Vice President Cheney and David Addington include: CIA Deputy Director Stephen Kappas, Chief of Staff and Counselor to the Vice President I. Lewis "Scooter" Libby, Deputy Chief of Staff for the Vice President C. Dean McGrath, Jr., Chief of Staff for the President Andrew Card, Senior Advisor to the President Karl Rove, White House Counsel Alberto Gonzales, Principal Deputy Assistants to the Vice President for National Security Affairs Eric S. Edelman, John P. Hannah, Samantha Ravich, and Joseph Wood, Special Advisor for National Security Affairs Robert Karem, Director of Advance Troy McNichols, Director of Scheduling Elizabeth Kleppe Pearce, Deputy Director of Scheduling Elyssa Larranaga, Executive Assistant in the Office of Chief of Staff for the Vice President Jennifer Mayfield, Assistants to the Vice President for Legislative Affairs Brenda Becker, Candida Wolff, and Joe Wall, Assistant for Political Affairs Michele Raines, Deputy Assistant to the President and Senior Speechwriter John McConnell, White House Press Secretary Scott McClellan, Assistant to the President for Communications Kevin Sullivan, Press Secretary Lea Anne McBride, Deputy Press Secretary Megan McGinn, Personal Aide Charles Durkin, Interpreter Gamal Helal, and Principal Deputy Assistant Secretary of State for Near Eastern Affairs Elizabeth (Liz) Cheney. Individuals depicted with Vice President Cheney and David Addington at the Economic Principals lunch meetings include: Secretary of Commerce Carlos Gutierrez, Secretary of the Treasury Henry Paulson, Chairman of the Council of Economic Advisers Edward Lazear, Directors of the National Economic Council Allan Hubbard and Keith

Hennessey, Directors of the Office of Management and Budget Jim Nussle and Robert Portman, White House Deputy Chief of Staff for Policy Joel Kaplan, and Assistant to the Vice President for Domestic Policy Neil Patel.

The photographs processed of Vice President Cheney with President George W. Bush includes images of them talking before meetings in the Oval Office and Outer Oval Office, walking on the White House grounds, having lunch together, riding in the Presidential limousine on their way to meetings at other facilities, waiting in holding rooms before official events and photo opportunities (photo ops), engaged in one-on-one conversations, and at policy team meetings at President Bush's Crawford, Texas ranch.

The photographs processed of David Addington by himself and with others includes: David Addington talking with President George W. Bush at President Barack Obama's swearing-in ceremony, meeting foreign heads of state, on foreign and domestic trips, at the Vice President's residence, at the swearing-in of Attorney General Alberto Gonzalez, in meetings and/or conversations with other staff members, and alone in his office.

The photographs processed depicting David Addington in conversations with other individuals include: President of Afghanistan Hamid Karzai, President of Iraqi Kurdistan Massoud Barzani, President Mahmoud Abbas of the Palestinian Authority, President of Romania Traian Basescu, His Holiness Pope Benedict XVI, United States Ambassador to Japan Howard Baker, CIA Director General Michael Hayden, Mrs. Lynne Cheney, Chief of Staff Andrew Card, Office of Vice President Staff Secretary Derrick Morgan, Director of the Office of Management and Budget Jim Nussle, Counselor to the President Edward Gillespie, White House Counsel Fred Fielding, Counsel to the Vice President Shannen Coffin, Deputy Assistants for National Security Affairs John P. Hannah and Samantha Ravich, Director of Advance Troy McNichols, Associate Deputy Director in Advance Katie Wilson, White House Press Secretary Dana Perino, Press Secretary Lea Anne McBride, Deputy Press Secretary Megan McGinn, Deputy Director of Operations Daniel Sox, Deputy Chief of Staff in Operations Claire O'Donnell, Executive Assistant Debbie Heiden, Special Assistant Lucile Tutwiler, Personal Aides Charles Durkin and Brian McCormack, White House physician Dr. Lewis Hofmann, Military Aide Lieutenant Colonel David Jones, Military Aide Major Timothy Stefanick, and military personnel at Bagram Air Base in Afghanistan.

The photographs processed of David Addington by himself include his official staff portraits, depictions of him behind the scenes at official events, reviewing documents, talking on a phone, viewing content on his blackberry, in his office at the White House, on airport tarmacs, and traveling on Air Force Two.

The photographs taken on September 11, 2001 processed for this request depict Vice President Cheney in his office at the White House on the morning of September 11, 2001, in meetings with senior staff members in the President's Emergency Operations Center (PEOC), in the PEOC listening to the President Bush's address to the nation with Lynne Cheney and First Lady Laura Bush, meeting with President George W. Bush in the PEOC later in the evening, and departing the White House on Marine Two with Lynne Cheney and I. Lewis "Scooter" Libby. Senior staff members depicted in the PEOC on September 11, 2001 include: Secretary of State Colin Powell, Secretary of Transportation Norman Mineta, National Security Advisor Dr. Condoleezza Rice, Deputy National Security Advisor Stephen Hadley, CIA Director George Tenet, Chief of Staff Andrew Card, Deputy Chief of Staff Joshua Bolten, Chief of Staff for the Vice

President I. Lewis “Scooter” Libby, Principal Deputy Assistant to the President for National Security Affairs Eric Edelman, National Security Council Counter-terrorism adviser Richard Clarke, Counsel to the Vice President David Addington, Counselor to the President Karen Hughes, Counselor to the Vice President Mary Matalin, Assistant to the President for Legislative Affairs Nicholas Calio, Air Force Lieutenant Colonel Kenneth Clark of the White House Military Office, and Naval Military Aide to the Vice President Douglas Cochran.

The photographs processed of meetings involving Department of Justice (DOJ) lawyers depict the following: Vice President Cheney with DOJ lawyers in photo ops and in meetings which included Attorney General Alberto Gonzales while touring the flood ravaged areas damaged by Hurricane Katrina in 2005. The photo ops include images taken on March 14, 2003 with Solicitor General Theodore B. Olson, Principal Deputy Solicitor General Paul D. Clement, Deputy to the Assistant Attorney General for the Civil Division Shannen W. Coffin and others who were part of the *Walker v. Cheney* defense litigation team. This series also includes photographs of Vice President Cheney in photo ops with Deputy Assistant Attorney General Alice Fisher of the Criminal Division and former Assistant Attorney General Michael Chertoff of the Criminal Division. The photographs with Attorney General Alberto Gonzales show Vice President Cheney meeting with local relief coordinators and emergency responders, on an aerial tour, and on a walking tour of the 17<sup>th</sup> Street levee repair operations in Louisiana with Governor Kathleen Blanco.

### **System of Arrangement**

Records responsive to this FOIA request were found in the Vice Presidential images collection from the White House Photo Office. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President George W. Bush.

The White House Photo Office assigned each image a unique number based on its roll and frame numbers. Identifying numbers for the Vice Presidential photographs begin with “V” in order to distinguish them from the Presidential photographs taken by White House photographers.

Images are reviewed and released at the item level in contrast with textual records which are reviewed at the folder level.

The responsive photographs retrieved from EOP ERA are saved in search results lists (SRLs) within the system. The following is a list of the SRLs saved and processed in response to FOIA 2014-0012-F:
