#### **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0121-F.

This series consists of email messages from October 2014 to April 2015 that include the company name "Rosemont Seneca." Many of the email messages include communications related to the India State Luncheon held on September 30, 2014, and the Japan State Luncheon held on April 28, 2015, which Hunter Biden attended. These records include White House guest lists, RSVP lists, table seating information, and menus. There are also email messages related to external scheduling requests for Vice President Biden including an invitation to speak at the Truman National Security Project annual conference on June 26, 2015, and a request for Vice President Biden to receive an award.

#### System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2022-0121-F [11]:

**Biden Vice Presidential Records: Electronic Records Exchange Email – Rosemont Seneca (2014-10-01 to 2015-04-30)** This SRL contains 154 responsive email messages.
