Scope and Content

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2022-0121-F.

This series consists of email messages from January 2012 through May 2013 that include the company names "Owasco," "Robinson Walker," "Lion Hall," and the name Rob Walker. The records include emails related to the St. Patrick's Day breakfast hosted by the Vice President on March 20, 2012, scheduling White House tours, and an unsolicited invitation to a September 27, 2012 book signing event for Paul A. Laudicina.

System of Arrangement

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2022-0121-F [13]:
