#### **Extent**

66 electronic files

#### Access

Collection is open to all researchers. #### **Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2023-0042-F.

This series consists of Vice President Joe Biden's daily timepiece schedules dated February 1, 2013 through July 21, 2014 which include his personal aide Fran Person along with Hunter Biden. Additionally, one of the schedules includes Devon Archer and another includes Jeffrey Cooper. These schedules document Vice President Biden's activities at the White House, the Naval Observatory and on foreign and domestic trips.

This series also consists of two email messages dated November 26, 2013 which were saved as electronic files within the Counsel's Office File Share. The email messages pertain to an article excerpt about Hunter Biden from the Politico Morning Energy newsletter.

#### **System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2023-0042-F [10]:

Biden Vice Presidential Records: Electronic Records Timepiece, 2013-02-01 to 2016-03-08

This SRL contains 48 responsive electronic files.
