**Scope and Content**

The materials in this series are a selective, not necessarily all inclusive, body of records responsive to the topic of FOIA case 2023-0042-F.

This series consists of an email message with duplicate copies forwarding Vice President Biden's briefing book for October 13, 2011. The email messages were sent by Stefanie Feldman to other Office of the Vice President staff members including Vice President Joe Biden's aide Fran Person. Some of the briefing book attachments mention Sara Biden, James Biden and Jeffrey Cooper. The briefing book documents official events related to the state visit of His Excellency Lee Myung-Bak, President of the Republic of Korea and Mrs. Kim Yoon-ok.

**System of Arrangement**

Records responsive to this FOIA request were found in the Biden Vice Presidential Electronic Records collection which includes email messages and electronic files. These records are maintained in the Executive Office of the President instance of the Electronic Records Archive (EOP ERA) which contains electronic records created or received by the administration of President Barack Obama. These electronic records are born-digital files and are primarily .eml, .pdf, .wpd, and .doc files.

The responsive electronic records retrieved from EOP ERA are saved in search results lists (SRLs) and are arranged chronologically by creation date.

The following is a list of the SRLs saved and processed in response to FOIA 2023-0042-F [13]:
