Seven (7) organizational units are responsible for planning: 1900 series (Administrative Management), 1910 (Resource Program and Assessment), 1920 (Land Management Planning), 1930 (Program Development and Budget), 1940 (Administrative Management), 1950 (Programs and Legislation-Environmental Coordinator), 1960 (Policy Analysis), 1970 (Policy Analysis), and 1990 (Research). A small portion of these records were included generally in schedule NN-166-136 file designations. The objective of planning in the Forest Service is to provide a sound basis for systematic decisionmaking at all levels in the organization, including provisions for controlling implementation, monitoring effectiveness, and when necessary, revising or amending approved plans. Five (5) Federal Acts provide the foundation for Forest Service planning: 1. Forest and Rangeland Renewable Resources Planning Act (RPA), 1974: as amended; 2. Multiple-Use Sustained Yield Act of 1960; 3. National Environmental Policy Act (NEPA) of 1969, as amended; 4. Cooperative Forestry Assistance Act of 1978; and; 5. Forest and Rangeland Renewable Resources Research Act of 1978.
