The records also provide information about the procurement procedure related to raw materials and ship building, the allocation of funds, and minutes to Maritime Commission meetings.

Included in the records are minutes of meetings, correspondence related to transportation and communications problems, and charts and maps. There are records that document labor relations, natural resources, and agricultural needs of the French North, and West African Colonies, as well as the French West Indies.

In addition there is information on the United Nation Relief and Rehabilitation Administration related to procedures and instructions on refugee problems in French North Africa. Included in these records are correspondence, and memoranda relating to the shipment of various types of commodities to these different areas of the world.
