JUSTIFICATION TO ACCOMPANY THE SF115 ON TABLE 75-6, RULE 1

This rule needs to be updated with clearer information on the local permissible operating distance that must be approved locally by the vehicle authorization/utilization board. The disposition as currently listed in AFR 12-50, table 75-6, rule 1, does not allow for the obsolete and/or superseded PODs to be destroyed. This change in language and disposition will adequately satisfy Air Force requirements.
