	<p align="center">ELECTRICALLY TRANSMITTED, CHART, AND FORECAST RECORDS (AFM 12-50, Table 105-2)</p> <p>Request a temporary waiver of AFM 12-50, Table 105-2, Rule 13, reducing retention period of weather forecasting briefing records from 3 months to 15 days at the Kansas City Air Route Traffic Control Center (ARTCC) for period 1 Sep 75 thru 29 Feb 76.</p> <p>The Kansas City ARTCC is conducting a joint test with FAA on issuance of weather forecasts in written and audio tape format. Test is being conducted in two phases. Phase I will use written forecasts which will be retained for normal 3-month period. During Phase II audio tapes will be used and retained for 15 days, with your approval.</p> <p>If the 15-day retention period is approved, approximately 36 tapes will be needed (\$850). If tapes must be retained for presently approved 3-month period, 200 tapes will be needed at a cost of \$4,800. Approval of 15-day retention for 6 month period will result in cost avoidance of about \$4,000.</p> <p>(Additional information is contained in our letter of 22 Jul 75, Subj: AFM 12-50 Waiver.)</p>	<p>NN 173-29</p>
