Engineering Manual 110-1-1804 establishes criteria and presents guidance for geotechnical investigations during the various stages of development for both civil and military projects. Geotechnical investigations are made to determine geologic, seismologic, and soil conditions that affect safety, cost effectiveness, design, and execution of a proposed engineering project. This schedule authorizes disposition for an estimated 20,000 cubic feet of unclassified geotechnical investigations records dating from 1800 to 2001 and stored at various Federal Record Centers. This schedule also applies to records maintained in USACE's regional offices and record holding areas (RHAs) including analog formats, textual, cartographic, photos, microfiche, and microfilm. This schedule does not apply to economic data records used in support of USACE Planning Guidance Notebook (Engineering Manual 1105-2-100) described in DAA-AU-2016-0018-0001.</p>
