Records of courts within the Denver District were abstracted on Form N-35 (Old 1-IP), containing last name, first name, address, certificate number or volume and page, title and location of court, country of birth or allegiance, date of birth or age, date and port of arrival in U S , date of naturalization, names and addresses of witnesses.
