The purpose of this order was to establish a coordinated Federal response to issues that particularly impact automotive communities and workers and to ensure that Federal programs and policies address and take into account these concerns. In July 2011, the President issued Executive Order 13578 to continue assisting auto communities and workers. While this executive order revoked the previous one establishing the Council, it delegates essentially the same responsibilities, but with the Secretary of Labor performing them instead of the Council. The Secretary of Labor created the Office of Recovery for Auto Communities and Workers.
