INFORMATION MEDIA GUARANTY PROGRAM (ICS/IMG)

The Information Media Guaranty Program was created under the authority of Title I of the Foreign Assistance Act of 1948 (PL 472). By the authority of Executive Order 10368, June 30, 1952, the IMG program was transferred from the Economic Cooperation Administration to the International Information Administration of the Department of State. It later came under the jurisdiction of the Information Center Service of the United States Information Agency. The IMG program provided for the conversion of foreign currencies into U.S. dollars that were earned abroad by U.S. producers of informational media, including books, audio recordings, and motion picture films.

13. Subject File of the Chief of the Information Media Guaranty Division, 1958-1972. 4 feet.

Arranged by subject. These records document the background, development, policies, and liquidation of the Information Media Guaranty program from approximately 1958-1972. The series includes correspondence with the Director of the USIA, legislative and background information, lists of approved and disapproved authors, copies of contracts and agreements with foreign countries, policy papers, and IMG study group reports.

OFFICE OF PRIVATE COOPERATION (IOC)

The Office of Private Cooperation was responsible for stimulating, guiding, and coordinating efforts of USIA to obtain the fullest possible use of the contributed services and facilities of nongovernmental agencies and groups to further the objectives of the U.S. information program. The office worked with private agencies such as business, industrial, fraternal, and non-profit groups having interests and capabilities in creating understanding abroad of U.S. aims. IOC was abolished effective July 1, 1967, as part of an economy and efficiency movement within USIA. Its functions were absorbed by the Office of Policy and Research (IOP) and by the Information Center Service (ICS).
