Under the new provisions, individuals are required to receive credit counseling and a budget analysis from a USTP approved nonprofit budget and credit counseling agency (agency) within 180 days prior to filing a bankruptcy petition. Also, an individual debtor is required to take a personal financial management course from a USTP approved debtor education provider (provider) before receiving a bankruptcy discharge. The United States Trustees approve credit counseling agencies and debtor education providers, with assistance from CC/DE, after determining that their qualifications meet the standards set forth in the Bankruptcy Code and related regulations. Once approved, agencies and providers can provide services to individuals and generate certificates to be filed with the courts evidencing fulfillment of the Bankruptcy Code requirements. |  |
