Item Description	<p>The data collected through NHTSA's Standing General Order 2021-01 (SGO) will help ODI in their investigations related to Advanced Driver Assistance Systems (ADAS) and Automated Driving Systems (ADS). The Order requires manufacturers and operators of vehicles equipped with Society of Automotive Engineers (SAE) Level 2 ADAS or SAE Level 3-5 ADS to report crash incidents of such vehicles. The data reported includes the subject vehicle information, incident information, incident scene, crash description, post-crash information a narrative that allows the reporting entity to provide details of the incident, such as the ADAS/ADS features engaged prior to and during the incident. The SGO shares the technical infrastructure with the Advance Retrieval (Tire, Equipment, Motor Vehicles) Information System (ARTEMIS), but ARTEMIS does not use or process data collected by the SGO. The data collected will be used by ODI for their investigations and by Chief Counsel (NCC) for legal and compliance purposes.</p>
