"Work folders" are primarily managed on shared or personal drives, and contain materials that meet the definition of a Federal record, relate to the specific programs of the component, and are related to mission-related activities. Political appointees in OSTP are limited to: the individuals in positions that are required to be appointed by the President and confirmed by the Senate; individuals in positions that are required to be appointed by the President; non-career SES employees; employees in Schedule C of the excepted service; and any advisors, experts, consultants, or detailees whose service is subject to change with the Presidential transition. Positions filled by the standard competitive process and career excepted positions are NOT included.</p>
